prints, it cannot be ruled out that certain amines, e.g. 4,4'-methylene-dianiline (MDA, CAS number 101-77-9) and 2,4-toluylen-diamine (TDA, CAS number 95-80-7) are released from the PU component and not from a banned azo colorant.

In case of pigment prints care has to be taken that 4,4'-methylene-dianiline (MDA, CAS number 101-77-9) is not released from a source of banned azo colorants but from e.g. a chemical fixing agent.
